
Confirming the Plan dated May 20, 2009 (the "Confirmation Order") before any Pass-Through Investor (including the Rev Op Group) is required to make its transfer decision.

- 2. The current deadline for any Pass-Through Investor to make its transfer decision is September 28, 2009. The Rev Op Group believes serious issues remain outstanding which need to be resolved before any Rev Op Investor should be required to make its transfer decision. Thus, an expedited hearing is requested in order to bring these issues before the Court.
 - 3. Pursuant to Local Rule 9013-1(h), the Rev Op Group advises as follows:
 - A. The email and office addresses for the attorneys for opposing and/or interested parties are set forth on the certificate of service hereto.
 - B. The facts showing the existence and nature of the emergency are outlined above.
 - C. The relevant parties will be served with the Motion for Clarification and this Motion via email immediately after such motions are filed with the Court.
 - D. Concurrently with the filing of this Motion, the Rev Op Group is uploading a form of order consistent with the relief requested in this Motion, a copy of which is attached to this Motion as <a href="Exhibit "A". Immediately after receiving a copy of a signed order from the Court, the Rev Op Group will serve such signed order on the parties set forth on the certificate of service hereto.

WHEREFORE, the Rev Op Group requests that the Court set an expedited hearing on the Motion for Clarification and grant the Rev Op Group any other and further relief as it deems just and proper under the circumstances presented herein.
