ML MANAGER'S MOTION TO CONTINUE ALL DEADLINES RELATING TO THE ISSUES RAISED BY MORTGAGES LTD. 401(K) PLAN

The Mortgages Ltd. 401(k) Plan is proceeding on several separate fronts. First, it filed a motion directing the release of fund currently held by the Liquidating Trust. Next, on August 30, 2010, prior to ML Manager's response deadline, the 401(k) Plan filed a motion to withdraw the reference to these issues [Docket No. 2901]. On that same day, the 401(k) Plan requested this Court from abstain from ruling on any of the issues that the 401(k) Plan initially raised. [Docket 2902]. Finally, the 401(k) Plan filed a separate declaratory judgment action in the District Court, case No. 10-cv-01862.

Accordingly, ML Manager respectfully requests that this Court extend all deadlines relating to issues raised by the 401(k) Plan until it is clear as to what venue it is most appropriate to decide these issues. This includes the resolution of the Motion with Withdraw the Reference, and its request for the Court to abstain from ruling on any issues that the 401(k) Plan raised.
