2005; Linda A. Reeves, Trustee of The Linda Ann Reeves Trust dated March 2, 2005; and John C. Vinson and Taeko Vinson, Trustees of the John Charles Vinson Family Trust dated December 3, 1984 (collectively "Appellants") hereby request transmission of the record on appeal to the United States District Court, District of Arizona. This Court issued its "Certificate of Readiness to Transmit Record on Appeal to Clerk of the U.S. Bankruptcy Appellate Panel" (Docket No. 2875), however, the record should be transmitted to the United States District Court, District of Arizona where this appeal is currently pending before the Honorable Murguia.

For the Court's convenience and information, and to help clarify the procedural issues in this appeal, Appellants give the following chronology:

May 27, 2010: Bankruptcy Judge, Randolph J. Haines issued his "Order Approving to Sell Real Property Free and Clear of Liens, Claims, Encumbrances, and Interests" (BK Docket 2770).

June 22, 2010: Bankruptcy Judge, Randolph J. Haines issued his "Order Denying Partitioning Owners' Motion to Amend Findings under Rule 7052 and to Alter or Amend Judgment under Rule 9023" (BK Docket 2790).

July 6, 2010: Appellants herein filed their "Notice of Appeal" in the underlying bankruptcy action (BK Docket 2806). With their Notice of Appeal, Appellants requested the matter be heard by the District Court. The Bankruptcy Court, however, disregarded that request because it was not contained in a separate statement.

July 12, 2010: Bankruptcy clerk issued "Notice of Filing Appeal and Notice of
Referral to the Bankruptcy Appellate Panel" ("BAP"). Following this, Appellants made a
formal request to BAP to refer the matter back to the District Court.

July 20, 2010: Appellants herein filed their "Designation of Record on Appeal and Statement of Issues to be Presented on Appeal" (BK Docket No. 2843)

July 29, 2010: ML Manager (Appellee) filed "Election to Have Appeal Heard by District Court" (BAP Docket No. 009153572).

August 2, 2010: BAP issues "Notice of Transfer of Appeal to District Court" and closed BAP Case No. 10-1245 (BAP Docket No. 009155465).

August 11, 2010: Bankruptcy clerk issued "Certificate of Readiness to Transmit Record on Appeal to Clerk of the U.S. Bankruptcy Appellate Panel" (BK Docket No. 2875)

August 13, 2010: District Court issues "Notice of Receipt of Appeal" [Received on August 4, 2010] (Docket 2 in the instant action).

It appears that the Bankruptcy clerk has not yet transmitted the record on appeal to this Court. Counsel for Appellants has contacted a District Court clerk in an attempt to get the Bankruptcy clerk to transmit the record on appeal to this Court. When that has occurred, this appeal can proceed and the briefing schedule can be established. Counsel for Appellants understands that certain internal transitions within the Bankruptcy Court, have temporarily delayed this process. Appellants respectfully request that the clerk of the Bankruptcy Court transmit the record to the District Court.
