**STIPULATION FOR ENTRY OF ORDER
REGARDING ROSENFIELD'S MOTION
TO COMPEL TURNOVER OF FUNDS**

25 Morley Rosenfield as trustee of Morley Rosenfield, M.D. P.C. Restated Profit Sharing
26 Plan ("Rosenfield"), and ML Manager, LLC ("ML Manager") hereby stipulate to the entry of the
27 attached Order to resolve all remaining issues with regard to Rosenfield's *Motion for Entry of an*
28 *Order Compelling Turnover of Funds Being Improperly Withheld by ML Manager* (the

1 “Turnover Motion”) dated June 2, 2010 (Docket No. 2771), and vacating the evidentiary hearing
2 arising out of the Turnover Motion scheduled for January 11, 2011. This stipulation does not
3 affect, however, the hearing also scheduled on January 11, 2011 on ML Manager’s (1) *Notice Of*
4 *Intent To Distribute Proceeds In Accordance With Allocation Model, And (2) Motion To Approve*
5 *Treatment Of Distribution Of Disputed Proceeds* (DE # 3017) (the “Distribution Motion”). It is
6 the parties’ intent and desire that the hearing on the Distribution Motion proceed as scheduled.
