On January 20, 2011, this Court approved ML Manager's distribution of funds pursuant to the allocation model (the "Distribution Order"). Stenberg Enterprises Profit Sharing Plan ("Sternberg") filed a motion for clarification seeking to clarify that ML Manager has accepted Sternberg's termination of the agency relationship that existed between Sternberg and ML Manager [Docket No. 3073]. Sternberg requested clarification that it was entitled to raise issues related to its share of costs in a separate evidentiary hearing. On February 11, 2011, Sternberg lodged a proposed form of order [Docket No. 3084].

ML Manager objects to the motion for clarification and the proposed order as these

documents are likely to lead to additional confusion over the status of the Distribution Order. Sternberg admits that he had no interest in the Loans that were the subject of the January 20, 2011, order and that Sternberg's issues were not discussed at the January 11, 2011 hearing. Sternberg has not pointed to any evidence that ML Manager intends to utilize the January 20, 2011, order to preclude Sternberg from resolving the issues regarding his agency. Indeed, ML Manager and Sternberg are agreed to a settlement to these very issues and are in the process of documenting that agreement.
