**MOTION FOR EXPEDITED HEARING RE:
EMERGENCY REQUEST FOR STAY AND
OBJECTION TO NOTICE OF NON-
COMPLIANCE AND LODGING A BENCH
WARRANT FILED BY RON BARNES**

13 Ron Barness ("Barness"), by and through his attorney undersigned, hereby moves this Court
14 for an expedited hearing on his *Emergency Request for Stay and Objection to Notice of Non-*
15 *Compliance and Lodging a Bench Warrant* since it is critical that the Court not sign the draft bench
16 warrant lodged on July 25, 2011 by ML Manager (Docket No. 3275). Barness learned after the June
17 15, 2011 hearing in this matter that he cannot draw cash against his credit cards. It is now impossible
18 for him to pay the \$112,075 owed to ML Manager. Barness requests that the Court stay its order
19 dated June 21, 2011 (the "Order") (Docket 3251) until such time that the Court can hear further
20 evidence and argument concerning this matter.

21 WHEREFORE, Ron Barness respectfully requests this Court hold an expedited hearing on
22 his *Emergency Request for Stay and Objection to Notice of Non-Compliance and Lodging a Bench*
23 *Warrant* at a date and time convenient to the Court.
