request as it related to the MK I and MK II, and granted the portion of the request related to the distributions on two of the loans. The Court in the signed Minute Entry stated "It is ordered granting the Motion. ML Manager shall make a distribution on undisputed portions of AZ CL and PDG Los Arcos by Friday April 13, 2011 without prejudice to ML Manager filing a motion to extend the deadline if it needs to for a demonstrated reason." (Docket No. 3482)(emphasis added).

Since the hearing, ML Manager has completed the updates of the Allocation Model as represented to the Court. ML Manager has transferred over \$22 million to Canyon State Servicing for the processing and payment of the checks to the approximate 1800 investors pursuant to the updated Allocation Model. Included in those funds are the undisputed proceeds to be paid to certain Rev Ops in the AZ CL and PDG Los Arcos. Canyon State Service has stated that because of the complexity of the task and the huge number of checks to be prepared and written and issued through the computerized system that it has set aside Saturday April 14 for this task. The checks will be written, sorted, and put in envelopes by Canyon State Servicing. As a result, ML Manager will not be able to meet the Friday April 13 deadline but requests that it be given an extension of 2 business days to distribute such funds.

In addition, counsel for ML Manager and the financial consultants and accountants that prepared the updated Allocation Model sat down face to face with Mr. Hawkins during the week of April 9 to go through the update and to answer his questions. Follow up will also take place so that he has the opportunity to review this information. Further, undersigned counsel has reached out to counsel for the Rev Op to discuss this extension and the Motion but was unable to reach him.

WHEREFORE, ML Manager requests that the Court grant this Motion and extend the deadline by 2 business days and grant ML Manager such further relief as is just and 6919339
