Whether the Bankruptcy Court erred in entering the Order Approving Distribution of Proceeds to Investors [Docket #3640] (the "Order") with respect to ML Manager's Motion to Authorize a Second Distribution of Proceeds in Accordance with Allocation Model and to Approve Treatment of Distribution of Disputed Proceeds [Docket #3257] and Motion to Authorize Distributions of Proceeds to Investors in Accordance with Allocation Model [Docket #3553] over the objections of the Rev Op Investors. Docket ##3257 and 3553 are referred to collectively as the "Motions."

- 2. Whether the Bankruptcy Court erred in entering the Order and granting the Motions despite its lack of authority and jurisdiction to approve any distributions under the confirmed plan of reorganization (the "Plan").
- 3. Whether the Bankruptcy Court erred in approving distributions in accordance with ML Manager LLC's ("ML Manager") so-called "Allocation Model."
- 4. Whether the Bankruptcy Court erred in allowing ML Manager to modify the Plan by surcharging funds owned by Rev Op Investors to cover expenses that are (i) the undisputed obligations of the liquidating trust under the interborrower agreement incorporated into the Plan, and/or (ii) specific to certain loans rather than "General Costs" to be allocated across all loans to all investors.
- 5. Whether the Bankruptcy Court erred in concluding that ML Manager's decision to make, and the implementation of, the distributions "are supported by the best business judgment of ML Manager which is consistent with ML Manager's fiduciary duties and responsibilities."
