**STATEMENT OF ISSUES ON APPEAL OF
SALE ORDER AND DESIGNATION OF
RECORD**

16 Pursuant to Federal Rule of Bankruptcy Procedure 8006, Queen Creek XVIII, L.L.C., its
17 successors and assigns (collectively, the “Rev Op Investors”), by and through their duly
18 authorized counsel, having appealed from the *Order Approving Motion to Sell Real Property*
19 [DE #3396] (the “Sale Order”), hereby submit their designation of items to be included in the
20 record on appeal and their statement of the issues to be presented on appeal. The Rev Op
21 Investors are collectively referred to herein as Appellants.

22 **I. DESIGNATION OF ITEMS TO BE INCLUDED IN THE RECORD.**

23 Appellants designate the items set forth in Exhibit A, attached hereto, for inclusion in the
24 record on appeal.

25 **II. STATEMENT OF ISSUES TO BE PRESENTED ON APPEAL.**

26 Appellants present the following issues on appeal:

- 27 1. Whether the Bankruptcy Court erred in entering the Sale Order.
- 28 2. Whether the Bankruptcy Court erred in finding that it had jurisdiction to approve

the sale as requested by appellee ML Manager LLC (“ML Manager”).

1 3. Whether the Bankruptcy Court erred in ruling that the purchase price offered
2 constitutes fair consideration for the subject property.

3 4. Whether the Bankruptcy Court erred in refusing to consider a competing offer for
4 substantially more money but otherwise on the same terms as the sale proposed by ML Manager.

5 5. Whether the Bankruptcy Court erred in ruling that ML Manager fulfilled its
6 fiduciary obligations to Appellants, particularly in light of the competing offer of purchase.

7 6. Whether the Bankruptcy Court erred in finding that the decision to sell and enter
8 into the sale agreement is supported by the best exercise of business judgment of ML Manager
9 consistent with ML Manager's fiduciary duties and responsibilities.

10 7. Whether the Bankruptcy Court erred in ruling that ML Manager, as agent for the
11 Appellants, has authority to sell the subject property and to execute any and all documents on
12 behalf of Appellants needed to consummate the sale.

13 8. Whether the Bankruptcy Court erred in ruling that ML Manager had an
14 irrevocable agency authority coupled with an interest with respect to the subject property where
15 ML Manager held no accompanying interest necessary to make the agency authority irrevocable
16 under Arizona law.
